## 1. Cookies Policy

When you enter the website (https://www.blueriver.co.th/) information related to entering the website Your data will be saved in the form of cookies. This cookie policy explains what it means, works, its purpose, and includes deleting and refusing to store cookies. For your privacy by accessing to this website, you have given us permission to use cookies in accordance with the Cookie Policy, detailed below.

#### 2. What are cookies?

Cookies are small files that stored information of your visit to a website, such as the date and time of the link clicked, the page visited. The terms of the settings are saved to your computer device and/or communication device accessed, such as a notebook, tablet or smartphone, via a web browser while you enter the website. The cookies will not harm your computer equipment and/or communication tools. In the following cases your personal data may be collected in order to enhance your experience of using the online services. It will remember the unique language and customize the usage information according to your needs. It's a unique confirmation of your safety information including the services you are interested in. Moreover, Cookies are also used to measure traffic of your online services, to personalize your content based on your previous and current browsing behavior and maybe for advertising purposes.

### 3. How does the company use cookies?

The company uses cookies to record your visits and sign-up to the website. To be easier for the company in order to remember your usage of the website.

This information will be used to improve the company's website in order to match more of your needs and for the convenience of your website usage. In some cases, the company requires a third party to assist, which may be required Internet Protocol Addresses (IP Addresses) and Statistical Analysis Cookies as well as linking information and processed for marketing purposes

The cookies used by the Company may be classified into two categories based on the storage:

- 1. Session Cookies are cookies that stay temporarily to remember you during your visit to the company's website, for example, to monitor the language you have set and choose to use, etc., It will be deleted from your computer or device when you leave the website or close the web browser.
- 2. Persistent Cookies are cookies that will last for the specified period of time until you delete them. These cookies allow the company's website to remember your settings when you return to use the website again. This will help you to access the website services more conveniently and quickly.

## 4. Purpose of cookies usage

- 4.1 These types of cookies are necessary for the service of the company's website. To allow you to access different parts of the website including the help to remember all information that you have provided through the website. To disable these types of cookies, you will not be able to access or use the company's website services that require cookies.
- 4.2 This type of cookie allows the company to be aware of user interactions while browsing the company's website services including pages or areas of the website that are popular; as well as other data analysis. The company also uses this information to improve the website functions in order to have the better user behaviors understanding, although this cookie information that is collected is non-personally identifiable and can only be used for statistical analysis only.
- 4.3 These cookies help the company's website to remember the setting that you have made, to help the website deliver additional features and contents that suits your usage. For example, to help remembering your account name and to remember the changes of font sizes setting or page settings which you can also customize. To disable these types of cookies may cause the website not functioning properly.
- 4.4 These types of cookies are created by the linking of the third-party websites which stores information of your usage and the websites you have visited in order to offer products or services from the other company's website services. To disable these types of cookies, it will not affect your website usage, but it will result the unmatched offers for the products or services on the other website.
